We invite scholars, judges and officials from different countries to join the Forum discussion which will be devoted to the most important issues of functioning of the system of the ECHR, as well as the practice of implementation of its provisions by the national states within the following main subject-areas:

- *philosophy of the European Convention;*
- *the principle of subsidiary as a basis for the implementation of the ECHR;*
- *different models of the ECHR implementation in national legal systems; and*
- *right to a fair trial.*
